

## REPORT:

### DELAWARE'S HEALTHCARE COST CRISIS REVEALED

A new survey of likely voters in Delaware reveals the toll that high-cost care and prescription drugs are taking on families across the state. The numbers are clear - many Delaware residents are delaying needed and cost barriers are preventing others from receiving treatment prescribed by a doctor — all realities that could lead to worse health outcomes.



## KEY FINDINGS

In the last year, more than 146,000 Delaware residents **did not seek treatment for a health problem due to cost of care.**

Over 585,000 Delaware residents **support allowing Medicare to negotiate with drug companies** to make drugs and medications more affordable to patients over letting drug companies set prices.

## SUPPORT FOR MEDICARE NEGOTIATING DRUG PRICES REMAINS HIGH IN DELAWARE

### 88% of voters in Delaware

support requiring drug companies to negotiate with Medicare for lower prescription drugs for all Americans.

### 77% of voters in Delaware

support imposing tax penalties to ensure that all drug companies negotiate affordable prescription drug prices with Medicare.

## METHODOLOGY

The findings are from a multi-channel survey of 619 likely general election voters in Delaware between April 29 - May 4, 2021. Interviews were conducted by live telephone and via web-based panel. Interviews conducted via web-based panel were matched back to a corresponding voter file. The confidence interval overall is +/- 3.9% within each state.
